

## Pou Chen announces monthly sales for June 2013

Date: July 10, 2013

Pou Chen Corporation (“Pou Chen”, Ticker: 9904.tw) today announced its unaudited sales for June 2013 was NT\$19,903 million on a consolidated basis. Pou Chen’s unaudited consolidated sales for January through June 2013 totaled NT\$110,670 million.

The aforesaid consolidated sales was unaudited, prepared by Pou Chen in conformity with the same accounting period. In addition, Pou Chen’s 49.98% owned major subsidiary, Yue Yuen Industrial (Holdings) Limited (“Yue Yuen”, Ticker: 0551.hk), changed its financial year end date from September 30 to December 31 since FY2012, which meant that FY2012 of Yue Yuen covered a period of 15 months from 2011/10/01~2012/12/31. Due to the aforesaid change of Yue Yuen’s financial year end date and Taiwan Stock Exchange’s regulations, the basis for preparing Pou Chen’s consolidated monthly sales of FY2012 will be different from that of FY2013. For example, Pou Chen’s consolidated sales for June 2013 included Yue Yuen’s monthly sales for June 2013; and Pou Chen’s consolidated sales for June 2012 included Yue Yuen’s monthly sales for March 2012.
